### Safe Vehicle Positioning at Traffic Incident Scenes

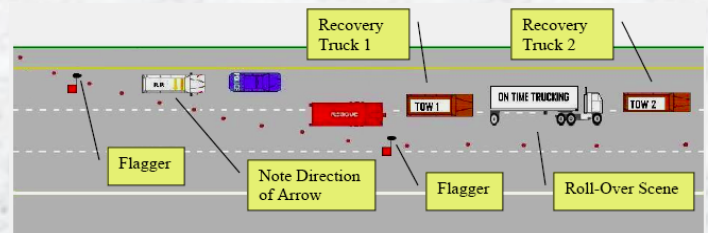
The TIM Teams are developing standard operating guidelines (SOG) for the safe positioning of responder vehicles at traffic incidents. The need for this initiative was identified by team members.

Examples of SOGs developed elsewhere are being gathered and reviewed by the newly-formed task group focusing on the issue to help standardize response procedures.

This effort is an ideal TIM Team project, as the Product will be from the Team and not from just a single agency.

The Scene Safety and Vehicle Positioning Task Group has a goal of obtaining good representation from all disciplines and all five of the corridor counties. The first task group meeting was held September 8; the next meeting is scheduled for the afternoon of October 9.

### ITS Coming to SW Florida

Intelligent Transportation Systems (ITS) deployment is imminent in the I-75 corridor. In the coming weeks, watch for:

- ☞ Construction to start on the Regional Transportation Management Center (RTMC) at the Daniels Pkwy rest area.
- ☞ Installation of CCTV cameras and vehicle detection equipment along the I-75 corridor.
- ☞ Deployment of a new 511 motorist information system in Collier, Lee and Charlotte Counties, and expansion of the current 511 system in Manatee and Sarasota Counties.

### Communicating with the Public Using ATIS During Disasters

An upcoming focus of the TIM Teams is effectively utilizing Advanced Traveler Information Systems (ATIS) to provide useful information to travelers during disaster situations. ATIS communication can include:

- \* Websites
- \* or other call-in telephone systems
- \* Push technologies – Reverse 911, Code Red, email, pager and text alerts
- \* Private sector travel information
- \* Radio and TV media
- \* Highway Advisory Radios
- \* Dynamic Message Signs (portable and permanent)

Both public and private sector ATIS operating agencies need to work together to provide timely, accurate and consistent information to those who need it.





### Lee MPO Launches website and “Blog”

The Lee County Metropolitan Planning Organization (Lee MPO) has launched its own website and Blog. These new venues are for public comments about, and involvement with, the Lee MPO's Long Range Transportation Plan and planning activities.
